Cookies

This website uses cookies. Cookies are small files that allow this website to store specific information relating to the user on the visitor's computer while visiting our website. VERANSTALTUNGS REGELN

Durch einen Besuch einer Veranstaltung von VC ARTFAIRS GmbH mit dem Sitz in Wien und der Geschäftsanschrift 1070 Wien, Siebensterngasse 46/1/44, eingetragen im Firmenbuch des Handelsgerichts Wien unter FN 580820y (im Folgenden kurz „VC“) unterwerfen Sie sich folgenden Veranstaltungsregeln:

1. Allgemeine Veranstaltungsregeln

- 1.1 Das Rauchen im Veranstaltungsort ist nur in den hierfür ausgewiesenen Bereichen zulässig. Außerhalb davon ist das Rauchen – einschließlich E-Zigaretten – verboten.
- 1.2 Das Betreten der Veranstaltung mit Haustieren, insbesondere aber nicht ausschließlich. Hunden, ist untersagt.
- 1.3 Besuchende stimmen einer Sicherheitskontrolle beim Betreten und Verlassen der Veranstaltung zu. Hierzu haben die Besucher dem Sicherheitspersonal oder sonstigem Personal von VC unaufgefordert die geöffnete Tasche vorzuweisen.
- 1.4 Das Anfertigen von Lichtbild- Video- und Audioaufnahmen zu kommerziellen Zwecken ist, sofern keine gesonderte schriftliche Genehmigung von VC vorliegt, untersagt. Darüber hinaus ist das Anfertigen von Foto- Film- und Tonaufnahmen nur unter Wahrung der entsprechenden urheberrechtlichen und datenschutzrechtlichen Bestimmungen zulässig.

EVENT RULES

By attending an event of VC ARTFAIRS GmbH with its registered office in Vienna and its business address at 1070 Vienna, Siebensterngasse 46/1/44, registered in the Commercial Register of the Commercial Court of Vienna under FN 580820y (hereinafter referred to as "VC"), you agree to the following event rules:

1. General Event Rules

- 1.1 Smoking on the event location is only permitted in the designated areas. Beyond these areas, smoking – including e-cigarettes – is prohibited.
- 1.2 Entering the event with pets, especially but not exclusively dogs, is prohibited.
- 1.3 Visitors to events agree to a security check upon entering and leaving the event. For this purpose, visitors have to show the opened bag to the security personnel or other personnel of VC without being asked.
